- C Traffic Calming Meeting - The next meeting of the Traffic Calming Committee with city officials is scheduled for November 2nd. At this meeting the city will present the results of the traffic study to our committee, then it will be up to the neighborhood to present our preferences for solutions to the city. George Bell, committee chair, wants these placed before city council before year end to be included in the 1999 city budget. He also indicated that we will need to have a meeting

Never Fear, Neighborhood Services Coordinator is Here!

Hartley Watson, the new Neighborhood Services Coordinator, spoke at the October Meeting of the Hampton-Pinckney Historic District. This was one of the most informative meetings yet for our neighborhood. Hartley described her position as that of a troubleshooter who will help us maneuver through city hall and organize the neighborhood association. Several problem areas were discussed:

- C Our sidewalks - The City of Greenville and the State of South Carolina scheduled a meeting in the near future between the city's department of public works and the state DOT. A bond referendum has been discussed as a means to fix and maintain all of the city's sidewalks.
- C Traffic Calming - Hartley is actively involved in our pursuit of traffic calming and determining how the Western Corridor will affect our neighborhood.
- C Landscaping - We asked how we could receive landscaping surrounding our neighborhood entrances, in particular at the intersection of Washington and Butler. Hartley indicated that the city did not have funds allocated for this type of project, and that it is quite involved to receive the proper permits to be allowed to do this. She indicated that the city's plans for Butler and

Washington are located on the 6th floor of City Hall for our viewing.

- C Trash - We asked how we could get trash cans or how we can reduce the amount of trash on the streets. Hartley suggested speaking with the local soup kitchens and restaurants to get them to work with us on this problem.
- C Organize and prioritize - Our neighborhood needs to re-establish the legal entities (incorporation and by-laws) and make a list of projects we wish to accomplish. We plan for the January meeting to be an open discussion to list all problems and concerns in the neighborhood so that all needs can be addressed. Hartley will then work with us on possible solutions.

We sincerely thank Hartley for joining us for the meeting.

Beautification of Pinckney/Butler Underway

A new project to beautify the corner of Pinckney and Butler on Pinckney Street beside Landrith Surveying has begun. Project coordinator,

Reid Taylor, has obtained permission for an easement along the Pinckney street side of the business for placing a fence and landscaping. He also met with the Greenville Tree Foundation to have trees planted at around \$120 per tree donation. He is looking for donations for building materials, the trees, and plant material. Reid is also asking for help with the manual labor of constructing the fence and planting. He will have more details at the meeting Tuesday night. - jb



The History Corner

Part of Hampton-Pinckney's architectural significance is derived from its concentration of Queen Anne style of architecture. It is a style that used features from several historic periods especially the Gothic and

Greek Revival styles. The Queen Anne style originated in England and emphasized picturesque effects in asymmetrical designs with complex roof and wall designs. During the 1890's and 1900's balloon frame construction



made it possible to create bay projections, turrets and irregular-shaped rooms that characterized this

architectural style. Exterior ornamentation often features patterned shingles, porch detailing with spindlework or brackets and classically inspired detailing such as porch columns, Palladian windows and cornices with



dentils. Hampton Pinckney has a number of remarkable Queen Anne homes from the height of the late Victorian phase (1880's - 1900's) such as:

The Rickman House at 17 Pinckney Street was built in 1905 by J.P. Rickman and is a striking example of the exuberance of the Queen Anne style. The Rickman house features a Dutch gambrel roof, wrap-around porch, gazebo, roof cresting, corbeled brickwork chimneys, and a porte cochere. It was

built to resemble the same design as Rickman's previous house in Hendersonville. It has nine fireplaces, inlaid oak floors, bevelled leaded glass windows and pocket doors. The third floor was the Victorian "male retreat" area and Mr. Rickman enjoyed his billiards on a massive pool table on this floor.

The J.M. Geer/Mahon House at 309 Hampton Avenue was constructed in 1894 by J.M. Geer and sold in 1898 to G. Heyward Mahon, a former mayor of Greenville. The turret, wrap-around porch and second floor balcony are distinctive characteristics of the Queen Anne style. It is interesting to note that the house was covered with asbestos shingles and the porch had wood columns prior to its rehabilitation in the late 1970's.

New Design Review Board

The City of Greenville disbanded the Board of Architectural Review (BAR) and replaced it with the Design and Preservation Commission (DPC). This new board is comprised of nine members and oversees exterior modifications, new construction design review for the downtown Central Business District (CBD), and local historic districts. Like the BAR, there are design guidelines which require approval by either the zoning administrator or DPC for exterior changes including but not limited to: paint color schemes, additions, alterations, and new construction (garages, fences, gates, signage, etc.). A new set of design guidelines will eventually be compiled after a grant is obtained from the State Department of Archives and History. Meanwhile, the existing guidelines remain in effect. Bryan Wood, Zoning Administrator (phone: 467-4476), should be contacted regarding questions and application procedures. -rb


